## Assessment of the ignitability of upholstered furniture EN 1021:2006

The tests have been carried out in accordance with the EN 1021-1:2006 "Ignition source: Smouldering cigarette" standard and with the EN 1021-2:2006 "Ignition source: Match flame equivalent" standard.

## Description of tested materials as declared by the client

Cover

Fabric "LUCKY" produced by CHIOCCARELLO S.r.I. Company, composition 100 % polyester, mass per unit area 400 g/m².

The exposed surface of the cover was tested, the cover has not been treated with a fire-retardant chemical.

Filling material (supplied by Laboratory as requested by the client)

Flame Retardant polyurethane foam (Crib 5), density 25 kg/m³.

## Pre-treatment and conditioning

The cover has not been subjected to the water soaking and drying procedure (Annex D) prior to being conditioned at least 96 hours at  $23 \pm 2$  °C temperature and  $50 \pm 5$  % relative humidity.
