## Assessment of the ignitability of upholstered furniture EN 1021:2014

The tests have been carried out in accordance with EN 1021-1:2014 "Ignition source: Smouldering cigarette" and EN 1021-2:2014 "Ignition source: Match flame equivalent" standards.

### Description of tested materials as declared by the client

Cover

Fabric SALO' produced by Chioccarello S.r.I. Company, composition 100 % polyester, mass per unit area 380 g/m2. The exposed surface of the cover was tested, the cover has not been treated with a fire-retardant chemical.

Filling material (supplied by Laboratory as requested by the client) Flame Retardant polyurethane foam (Crib 5), density 25 kg/m3.

#### Pre-treatment

The cover has not been subjected to the water soaking and drying procedure (Annex D).

#### Conditioning

At least 96 hours at 23  $\pm$  2 °C temperature and 50  $\pm$  5 % relative humidity.
